**MOTION FOR ORDER DIRECTING INDIANA BUREAU OF  
MOTOR VEHICLES TO ISSUE REPOSSESSION TITLES**

James A. Knauer, Receiver in the above captioned cause, by counsel, in support of his *Motion for Order Directing Indiana Bureau of Motor Vehicles to Issue Repossession Title*, states:


1. The undersigned was appointed as a Receiver in these proceedings on August 21, 2000.
2. The September 15, 2000 stipulation entitles the Receiver to assemble and sell Danker's assets, including a 1991 Harley Davidson motorcycle, VIN #1HD1BLL11MY019697.
3. The Receiver has obtained possession of the Harley Davidson motorcycle but does not have the title.
4. In order to sell the motorcycle, the Receiver needs to obtain a repossession title in his name as Receiver for Daniel G. Danker.
5. A copy of the Official Indiana Title and Lien Record showing that Daniel G. Danker is the owner of the Harley Davidson motorcycle is attached hereto as Exhibit "A".

THEREFORE, the Receiver requests that the Court direct the Indiana Bureau of Motor Vehicles to issue a repossession title for the motorcycle described on Exhibit "A" in

the name of James A. Knauer as Receiver for Daniel G. Danker and for all other proper relief.


