
ENTRY AMENDING MARCH 2, 2011 ORDER

On March 2, 2011, the Court issued an Order in response to Receiver James A. Knauer’s Final Report, noting, in part, that it had not received any objections to the Receiver’s Final Report. [Dkt. 47 at 1.] Defendant Kenneth R. Payne mailed an objection dated February 18, 2011 to the Clerk of this Court. Due to a delay in docketing, however, Mr. Payne’s objection was not posted on the docket until March 4, 2011. [Dkt. 49.] Therefore, the Court strikes the last sentence of the first paragraph of the March 2, 2011 Order and replaces it with the following:

Mr. Payne filed an objection to the Receiver’s Final Report. Mr. Payne’s objection will be considered when the Court addresses the Receiver’s professional fee request. No other parties filed an objection.
