This cause is now set for a **court trial on Monday, June 3, 2002, at 9:00 a.m. in Room 307** of the United States Courthouse in Indianapolis, Indiana.


A final conference will be scheduled sometime the week before trial. The court will contact counsel approximately a month prior to the trial date to schedule that conference.

A brief informal telephone status conference will be held on **April 30, 2002, at 10:00 a.m.** **The parties should call the court at 317-229-3963 for the "meet me" conference call.** This number is used only for the purpose of the conference call and is only available at the date and time designated.¹

The topics of this conference shall include the likelihood of the case going to trial, the expected trial length, the trial readiness of the case and related topics. The telephone conference should last no more than fifteen minutes.

The court does not anticipate scheduling any other pretrial conferences in this case. If it is later determined that such a conference would be useful, it would be set on an "as needed" basis, by either the District Judge or the Magistrate Judge with sufficient prior notice to the parties. The parties may also request pretrial conferences as needed to resolve issues in the case, as well as for settlement discussion purposes.
